SEC 4. (1) (b) (vii) THE PARTICULARS OF ANY ARRANGEMENT THAT EXISTS FOR CONSULTATION WITH, OR REPRESENTATION BY, THE MEMBERS OF THE PUBLIC IN RELATION TO THE FORMULATION OF ITS POLICY OR IMPLEMENTATION THEREOF

This office acts in close liaison and consultation with the State Government as well as prominent local Industrial Associations in the formulations and implementation of the developmental scheme, regulatory work, etc. of Government of India. The Officer In-charge of this Office, explains the various developmental Schemes of the Government of India as well as the functions and activities of this office including consultancy services, trouble shooting assignments, preparation of project reports etc., to the public during every awareness / facilitation programmes / seminars / workshops. The members of public are free to give feedback / suggestions for the implementation, modifications and formulation of policies / schemes / activities for the overall development of textile industry. Our field officers are also in various committees.

Over and above informal meetings and consultation with the stake holders of the Textile Industrial Trade, certain formal committee / board are also constituted for various purposes. The major committees are given below:

- 1. Committee on Cotton Production and Consumption (COCPC):
 - a. Government of India, Ministry of Textiles vide its letter No.11/31/2020-Fibre-I dated 14.09.2020 has formulated a Committee on Cotton Production and Consumption (COCPC) for estimation of data on production, supply, demand, export and closing stock of cotton etc.
 - b. MOT vide letter No.11/18/2022-Fibre-I dated 25.05.2022 had formulated the Textile Advisory Group (TAG) an informal body to deliberate and recommend on the issues pertaining to the entire cotton value chain.
- 2. Hank Yarn Price Monitoring Committee: The committee under the chairmanship of Tx.C. to take stock of the availability and price of hank yarn, the major raw material for the handloom sector.
- 3. TAMC Technical Advisory cum Monitoring Committee .The committee meets whenever necessity is there.
