**Report on The Activities Under Taken between**  
**09/08/2017 to 15/08/2017 in respect of**  
**Commemoration of 75<sup>th</sup> anniversary of the Quit India**  
**Movement.**

This organization has undertaken various activities throughout India through its Regional Offices and Powerloom Service Centers. The set of Activities undertaken in Hqrs Office, Mumbai, all Regional Offices and Powerloom Service Centers are as under:-
