

MINUTES OF THE 3rd MEETING OF THE TECHNICAL ADVISORY AND MONITORING COMMITTEE (TAMC) UNDER A-TUFS HELD ON 30/03/2016 AT OFFICE OF THE TEXTILE COMMISSIONER, MUMBAI-20

The 3rd meeting of the TAMC under A-TUFS was held under the Chairpersonship of Dr. Kavita Gupta, IAS, Textile Commissioner on 30/03/2016 at 3.00 PM in the Conference Hall of the Office of the Textile Commissioner, Mumbai. A list of participant is enclosed at Annexure-I

2. At the outset, the Textile Commissioner welcomed all the participants and informed the members that initial discussion was already held in the last meetings held on 07/03/2016 and 14/03/2016 respectively. She also informed the members that comprehensive software for Pending RR-TUFS and A-TUFS is prepared and will be operative from 04/04/2016 on test run for short period and thereafter will become operational.

3. The Textile Commissioner also emphasized that A TUF Scheme is for the purpose of promoting the use of upgraded technology in Textile sector so as to enable the growth of the Textile sector at the different level of growth trajectory. Therefore the principle which is followed to determine the eligibility of the machinery for A TUFS scheme would be against a clear cut satisfaction on whether the machinery is an upgraded version as compared to the machinery which are being used at present. She therefore further clarified that these machines would also be an upgradation over the machinery permitted under RR TUFS and the same have also to be revised in each consecutive TAMC which will decide on the eligible machinery annually.

4. Thereafter, agenda points were taken up for discussion.

Agenda No.1. : Confirmation of the minutes of the First and Second TAMC meeting held on 07.03.2016 and 14.03.2016, respectively.

5. The minutes of these meetings were also circulated among the members along with list of the machinery to be covered under A-TUFS for comments/suggestions, if any. After deliberation on some of the suggestions, the minutes of these meetings were confirmed and taken on record.

Agenda No.2. : To finalize the list of eligible machineries under Amended Technology Upgradation Fund Scheme for Handlooms, silk and Jute and to identify/ finalize the list of energy saving machinery/ device and equipments.

6. MC 1 to MC 4 were finalized in the last meeting of TAMC which were confirmed with some modifications. Further the list of machinery for other segments namely, Handlooms, Silk and Jute Segments are also finalized. Below mentioned annexures of the finalized eligible machinery under ATUFS are enclosed:

- a) MC-1 - Weaving, Weaving Preparatory and Knitting
- b) MC-2 - Processing of fibres, yarns, fabrics, garments and made-ups.
- c) MC-3 - Technical Textiles
- d) MC-4 - Garment/Made up manufacturing
- e) MC-5 - Handlooms

- f) MC-6 - Silk
- g) MC-7 - Jute

Similarly, a list of Energy Saving Machine/Devices/Equipments is also finalized as **MC-1 (A)** for Weaving, Weaving Preparatory and Knitting and **MC-2 (A)** for Processing of fibres, yarns, fabrics, garments and madeups, respectively. In this regard the Committee decided that priority will be given for issuance of UID under ATUFS if the cost of the Energy Saving Machinery/Device/ Equipments as listed in above said MC-1(A) and MC-2(A) proposed under the project are more than 50 % of the cost of all eligible machinery under ATUFS in the project or the eligible machineries installed under ATUFS in the project are run by Solar Power to the extent of at least 50% of the total power consumed in the unit. **In case, the unit has obtained UID under Energy saving preference and it is found proper by the JIT that the energy saving criteria as defined above are not met then the UID issued would be liable for cancellation.** In such circumstances, the unit may however apply for a new UID afresh.

The Chairperson informed that the list of machinery as approved by the Committee will be notified by a Circular, accordingly.

Agenda No.3. : Finalization of list of machinery manufacturers/ suppliers under ATUFS.

Office of the Textile Commissioner has requested Textile machinery manufacturers association like (TMMA and ITMMA) and also sent letters to Consulate General of various countries in India and Indian Embassies in abroad. In reply OTXC has received the list of machinery manufacturers in India from TMMA and ITMMA. Further OTXC has also received the list of machinery manufacturers from some of the Consulate General and Indian Embassies. The details of machinery manufacturers were discussed in the meeting and the Committee decided that the list may be considered as an indicative list and the same may be notified by a circular.

Further it was also decided that this **list of manufacturers are to be considered as indicative for generation of MIC (Machinery Identification Code) and may not be considered as benchmarked manufacturer to become eligible under ATUFS. The new names of the manufacturers, if any received subsequently will be notified separately.**

Additional Agenda No.1. : Representation from Focal Point Industrial Welfare Association, Amritsar for maintaining the status quo of the machineries for cases sanctioned on or before 12.01.2016:

The matter was discussed and it was observed by the committee that the matter relates to policy decision and involves financial implication. As such, the same may be placed before the forthcoming meeting of IMSC for decision.

Since there was no other agenda the meeting ended with vote of thanks to the Chair.
